The Edmonton Social Planning Council (ESPC) had been on the "at risk" species list among the United Way member agencies.

However, rather than heading in the direction of an endangered species, the Council has revived and is headed for a bright future.

Since the last Annual General Meeting, the Council has met many challenges, produced a significant amount of quality social planning research and well-balanced published opinion.

Over the past year, under the effective leadership of our Executive Director, Susan Morrissey, the Council has moved from its old location, revived the resource room, coped with significant staff changes, produced the fACTivist, begun work on making the website more interactive and user-friendly, and after a hiatus too long to report here, published the 2007 edition of *Tracking the Trends*.

Other accomplishments are detailed throughout this report.

On governance matters, the Board of Directors of the ESPC has seen several changes in membership through resignations and secondments during the year.

There is one long-serving member of the Board who has reached the end of his term. Treasurer Terry Andersen has worked diligently on improving our accounting and other internal procedures and made a big contribution to developing a dynamic website. # **Public Interest Alberta ESPC Active on PIA Living Wage Task Force**



#### **Public Interest Alberta**

The Council has been an active member of Public Interest Alberta's Living Wage Task Force since its inception. The task force is a network of representatives from non-profit organizations across Alberta who are working on the issue of low wages. The aim of the task force is to ensure that anyone

working full-time earns enough income to maintain a safe, healthy standard of living.

In fall 2006, PIA contracted the ESPC to produce a report outlining the results of its province-wide survey, which asked Albertans to estimate the cost of maintaining a safe, healthy standard of living in their communities. The report, released in early 2007, also analyses recent data on income and employment. The report will serve as the foundation for PIA's future advocacy around establishing Living Wage policies at the municipal and provincial levels.

# Action for Healthy Communities ESPC Begins Evaluation: Voices from our Neighbourhoods



Since early 2006, the Council has supported Action for Healthy Communities in making its vision of the *Voices from our Neighbourhoods* project a reality. The project aims to empower and engage the members of 10 inner city neighbourhoods by bringing them together to discuss and explore the issues in their communities. This will be done through a series of dialogue sessions and the development of interactive projects to be led by community members.

In the fall of 2006, Action for Healthy Communities contracted the ESPC to be the external evaluator for the *Voices* project. The current contract expires in fall 2007, and the Council hopes to have it renewed for the remaining two years of the project.

He has served on many boards and committees, including the Edmonton Public Library and the Capital Region United Way, and has been active in the Council of Canadians and the Edmonton Coalition Against War and Racism.

Doug has been working for a health care labour union since 1999. He joined the ESPC Board in 2005, becoming President in 2006. Doug lives in the Old Strathcona neighbourhood with his wife.

#### 1. Welcome and President's Remarks

The meeting was convened by Jenny Wong, President of the Edmonton Social Planning Council, who welcomed everyone and delivered a brief opening statement. Jenny welcomed special guest, David Eggen, MLA - Calder, as well as introduced her fellow ESPC Board of Directors.

#### 4. President's Report

Jenny Wong reflected on the previous year and the accomplishments of the ESPC in 2005. Jenny pointed to the recent appearance of the ESPC paper Creating Social and Health Equity: Adopting an Alberta Social Determinants of Health Framework on the World Health Organization's website, indicating the broad audience the ESPC has begun to reach. The ESPC continues to be a voice for the people, advocating on their behalf.

Jenny recognized the efforts of current and previous ESPC staff, including Phil O'Hara, Dianne Henshaw and John Pater, in being key reasons as to why the ESPC was successful in the previous year, and who helped to lay the groundwork for current initiatives.

While in recent months the ESPC has undergone changes, Jenny eloquently stated that while change has been difficult, it is also necessary to grow and prosper. The future often holds unknown elements, but Jenny hopes that the Board and ESPC members will take an active part in the future of the organization.

#### 5. Operational Report

Jenny Wong introduced Susan Morrissey, Executive Director, who delivered the operational report for the year 2005. Susan recently joined

the ESPC in October 2005, and spoke of how she was first struck over the diversity of the programs and issues that the ESPC dealt with. In terms of specific issues, Susan highlighted numerous ones:

#### Relocation in the fall 2006

The ESPC will be moving offices this fall, relocating to a building close to its current location. Unfortunately, the move will no doubt change the face of the Sacred Heart Collective.

#### Strategic Alliance

While there have been no policy changes as of yet, one must understand that such changes take time. However, the ESPC has influenced the Alberta Health and Wellness (AHW), speaking directly with AHW representatives who are looking at ways to change their procedural process.

The ESPC is also implementing its goal of reaching out to the community more, initiating contact with community groups and representatives, involving more individuals and groups in an attempt to better its network.

ESPC will be once again re-establishing its resource and archive room, a resource that was used in the past by many individuals in social policy. The popular publication Tracking the Trends will soon be published due to high demand.

Susan thanked the previous and present staff for their hard work in the past, and their continued commitment to the ESPC in the future. She also said a special thanks to the Board of Directors, stating that they have both challenged and educated her. As a result of the Board's wrok, the ESPC held a successful fundraising Casino.

#### 6. Finance Committee Report

Michael Austin stated that the ESPC Board of Directors had received the financial report for the 2005 year. He then introduced Michael Epp to deliver the financial report.

#### 7. Presentation of Financial Report

Michael Epp, of Hawkings Epp Dumont, reviewed the audited financial statements of the Council, reporting on behalf of the Board to the members, and on behalf of Trevor Dodd, who performed the on-site audit. The financial statements were reviewed by both the Finance Committee and the Board prior to this meeting.

Mr. Epp stated he was pleased with the audit results and process, stating that the ESPC is in good, solid financial position to carry out its duties. While the ESPC is not in the business of making money, its concern lies with fulfilling its mandate.

Although there was an operating deficit of \$9,000, the Council has accumulated \$91,000 in unrestricted surplus during its 66 years in operation, which is a solid financial resource to draw upon. Revenue and expenses decreased from the previous year, which Mr. Epp attributed to the fact that the Edmonton Centre for Equal Justice financials was no longer being included within the Council figures.

Mr. Epp presented numerous graphs that depicted the sources of revenue and expense for the Council, comparing the year's figures to previous years. Mr. Epp noted that overall there has been little change across categories, although an increase in revenue for advocacy occurred this year. Salaries continue to form the largest expense, which is typical for a non-profit organization.

Joscelyn Proby reported that the Nominating Committee has held several meetings regarding future Board members, stating that there is continued interest from members of the general public to serve on the Board of Directors. Joscelyn then opened the floor for nominations. However, there were none at the time.

#### 9. Recognition of Retiring Board Members

The only retiring Board member was Jenny Wong, whom Joscelyn Proby spoke about. Jenny served on the Board for four years, and stepped forward to become President during the summer. Jenny proved graceful under pressure during this challenging time, showing her leadership strength and determination to see the ESPC thrive once again.

On behalf of the other Board of Directors, the ESPC staff, and the ESPC membership, Joscelyn thanked Jenny for her hard work, wishing her and her fiancée all the best in their upcoming nuptials. Susan Morrissey presented Jenny with a token of appreciation.

#### 10. Other Business

Douglas Meggison opened the floor for nominations once again. Due to vacancies, Doug asked for an open call for nominations. The ESPC policy is that there is to be 10-15 members on the Board, and now, due to circumstances, only 8 are currently serving. However, another policy states that the Board of Directors can continue to operate if the number of members happens to fall below the minimum. Joscelyn remarked that the Nominating Committee is currently holding interviews and will soon be appointing new Board members.

#### 11. Adjournment

There being no further business, Jenny Wong adjourned the meeting.
